MINUTES OF THE ANNUAL (912TH) MEETING OF BUDOCK PARISH COUNCIL HELD AT BUDOCK VILLAGE LOWER HALL ON MONDAY 21ST MAY 2018

PRESENT: Clirs Bastin, Bennett (Chairman from Minute 18-25), Bownas, Clark, Fairbank, Hart (Chairman until Minute 18-25), Hennell and Heritage.

IN ATTENDANCE: Mrs L Iddon, Clerk.

There were no members of the public present. The Council meeting commenced at 7.30pm with the Chairman explaining the Safety Procedures.

18-24 TO RECEIVE AND ACCEPT APOLOGIES FOR ABSENCE

Apologies were received and accepted from Cllrs Geraty (out of the area) and Palmer (working).

18-25 TO ELECT A CHAIRMAN FOR THE YEAR 2018/19

Cllr Hart advised that he did not wish to stand for election as Chairman. Cllr Fairbank proposed Cllr Bennett to be Chairman, this was seconded by Cllr Hennell and:-

RESOLVED that there being no other nominations Cllr Bennett, with his agreement, be elected Chairman for the Year 2018/19.

On a vote being taken this was approved unanimously.

The Acceptance of Office document was completed and Cllr Bennett took over as Chairman.

Cllr Bennett thanked Cllr Hart for all his hard work over the last 2 years.

18-26 TO ELECT A VICE CHAIRMAN FOR THE YEAR 2018/19

Cllr Heritage advised that he did not wish to stand for election as Vice Chairman due to his commitment to Chairing the NDP Steering Group.

Cllr Bennett proposed Cllr Fairbank to be Vice Chairman, this was seconded by Cllr Hart and:-

RESOLVED that there being no other nominations Cllr Fairbank, with his agreement, be elected Vice Chairman for the Year 2018/19.

On a vote being taken this was approved unanimously.

18-27 MEMBERS TO DECLARE ANY DISCLOSABLE PECUNIARY AND NON REGISTERABLE INTERESTS AND ANY GIFTS OR HOSPITALITY OVER £25 None were declared.

18-28 TO CONSIDER REQUESTS FOR DISPENSATIONS FROM MEMBERS

None were requested.

18-29 TO RECEIVE AND APPROVE THE MINUTES OF THE COUNCIL MEETING HELD ON 30TH APRIL 2018 AND THE CHAIRMAN TO SIGN THEM

It was proposed by Cllr Hart and seconded by Cllr Fairbank and:

RESOLVED that the minutes of the Council Meeting held on the 30th April 2018 are received and approved.

On a vote being taken this was approved with one abstention. The Chairman then signed them.

18-30 TO REPORT MATTERS ARISING FROM THE MINUTES NOT ON THE AGENDA (for information only) The Clerk reported on the following:-

- Letter received from The Forestry Office regarding the TPO request for trees on Kergilliack Road this has been turned down.
- Viv Bidgood (Highways and Environment) plans to be in Budock Village Hall at 2pm on Friday 21st September to meet with a group of Councillors. This will be bought forward if Cornwall Council's Speed Visor Policy is produced well before then.

18-31 TO RECEIVE ANY POLICE UPDATES

18-32 TO RECEIVE A NEIGHBOURHOOD PLAN UPDATE AND TO CONSIDER ANY ACTIONS REQUIRED Cllr Heritage reported the following:-

- The local housing need is still being looked into.
- The Group is working towards producing a Draft Plan.
- A 'Drop-in Day' is being held in Budock Village Hall on Saturday 9th June where information gathered so far will be displayed. The aim of this will be to publicise the work done by the NDP Steering Group and to encourage further feedback. A similar event is planned for Treverva Village Hall during the summer.
- The Group are aware of the impact the new GDPR will have and the Parish Council Clerk will liaise with the Secretary of the Group with regard to this and actions needed.
- The Steering Group has produced a draft Vision Statement this was shown to all the Council for approval. It will be on the NDP website in due course and form part of the Plan.

It was proposed by Cllr Heritage and seconded by Cllr Fairbank and:-

RESOLVED that the Vision Statement for the Budock NDP Steering Group is agreed.

On a vote being taken this was unanimously approved.

18-33 TO CONSIDER AND APPROVE THE COUNCIL'S 'STATEMENT OF INTERNAL CONTROL' FOR THE YEAR ENDING 31ST MARCH 2018

It was proposed by Cllr Hennell and seconded by Cllr Bownas and:-

RESOLVED that this Statement of Internal Control is accepted.

On a vote being taken this was unanimously agreed.

RESOLVED that the Governance Statements as agreed are approved and signed by the Clerk and Chairman.

On a vote being taken this was unanimously agreed.

18-35 TO RECEIVE AND APPROVE THE END OF YEAR ACCOUNTING STATEMENTS FOR THE YEAR ENDING 31ST MARCH 2018

All Councillors had been sent a copy prior to the meeting.

It was proposed by Cllr Hennell and seconded by Cllr Hart and:

RESOLVED that the End of Year Accounting Statements are approved and signed as appropriate.

On a vote being taken this was unanimously agreed.

18-36 TO RECEIVE THE INTERNAL AUDIT REPORT FOR THE YEAR ENDING 31st MARCH 2018

This was received and all were made aware of the recommendations and comments of the Internal Auditor.

18-37 TO CONSIDER THE PROPOSAL THAT FUTURE COUNCIL MEETINGS SHALL COMMENCE AT 7.30PM WITH ANY PUBLIC PARTICIPATION TO BE TAKEN AS THE FIRST ITEM

It was proposed by Cllr Fairbank and seconded by Cllr Mrs Clark and:-

RESOLVED that future Council Meetings shall commence at 7.30pm with any Public Participation to be taken as the 1st item and limited to 15 minutes in total, (3 minutes per speaker). This rescinds the resolution made in October 2017 (Minute 17-137).

On a vote being taken this was unanimously agreed.

18-38 TO DISCUSS THE IMPACT OF THE GENERAL DATA PROTECTION REGULATIONS (GDPR) ON THE PARISH COUNCIL

The Clerk and Cllr Hart recently attended a training session on the new GDPR. An update was given and the Parish Council will be working towards full compliance. Guidance is being given by CALC.

18-39 TO CONSIDER APPOINTING A TREE WARDEN FOR BUDOCK PARISH

Information regarding appointing Tree Wardens has been received from the Forestry Office of Cornwall Council. It was proposed by Cllr Heritage and seconded by Cllr Hart and:-

RESOLVED that Budock Parish Council register an interest in this and ask to be kept in touch with any relevant information.

On a vote being taken this was unanimously agreed.

18-40 TO DISCUSS THE CERTIFICATE OF LAWFULNESS APPLICATION FOR LAMANVER SHED

After much discussion it was proposed by Cllr Hennell and seconded by Cllr Bastin and:-

RESOLVED that the Environmental Health department at Cornwall Council is made aware of the concerns there are over drainage and sewerage issues at this site.

On a vote being taken this was unanimously agreed.

18-41 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL DIVISIONAL MEMBER

- A full Council Meeting is taking place tomorrow (22nd May).
- The Menehay Fields Appeal has just been heard (4¹/₂ days). The Inspector will make his rec0mmendation but the final say will be made by the Secretary of State.
- Traffic issues on Bickland Water Road were discussed at a meeting between Councillors and Cormac. The traffic lights will be in place until the roundabout is completed an estimated date of November this year.
- Cllr Bastin is meeting with Persimmon later this week to discuss various issues including the access made through the hedge on Hillhead Road and the fencing off part of a field/ public footpath at the end of Gypsy Lane.
- Taylor Wimpey intend to close the 'road' across Poolfield from the end of June. Many concerns regarding the suitability of an alternative route for children walking to school had been received.
- The Boundary Commission Review has been deferred until August.
- Planning Enforcement will no longer be producing lists of their current cases due to the impact of the new GDPR. Updates will only be given to those who raised the issues.

On a vote being taken this was approved with four abstentions.

 ii) PA18/03838 – New 2 storey and first floor extension with new glass green house and replacement of existing porch – 2, College Wood, Penryn – Mr & Mrs Fergusson It was proposed by Cllr Hart and seconded by Cllr Heritage and:-

RESOLVED that the following Comment be submitted:- 'Budock Parish Council support this application'.

On a vote being taken this was approved with one abstention.

iii) PA18/03939 – Reserved matters of appearance, landscaping, layout and scale following outline permission PA16/03214 for erection of a new dwelling and access – Penrose, Penjerrick Hill – Mr Courage, RC Construction Cornwall Ltd

After discussion it was proposed by Cllr Fairbank and seconded by Cllr Hart and:-

RESOLVED that the following Comment be submitted: - 'Budock Parish Council has no objections to this application. However they do have concerns about the potential height of the proposed dwelling in relation to the adjacent property'.

On a vote being taken this was approved with one abstention.

iv) PA18/ PA18/04036 – Non material amendment (2) for alterations to Units E1, E2 and E3 (Block F) to provide additional windows / glazing in respect of appeal decision APP/D0840/A/12/2172374 dated 25.10.2012 (PA11/09595) – Bickland Industrial Park – Falmouth Developments Ltd

After further study of the plans provided it was proposed by Cllr Fairbank and seconded by Cllr Hart and:-

RESOLVED that the following Comment be submitted:- 'Budock Parish Council are unable to comment on this application as they are unable to identify the site (Block F) from the documents provided'.

On a vote being taken this was approved with one abstention.
