MINUTES OF THE 899TH MEETING OF BUDOCK PARISH COUNCIL HELD AT BUDOCK VILLAGE HALL ON MONDAY 27TH FEBRUARY 2017

PRESENT: Cllrs Bastin, Bennett, Mrs Clark, Fairbank, Geraty, Gibson, Hart (Chairman), Hennell, Heritage and Palmer.

A minutes silence was held at the start of the meeting in memory of former long serving Parish Councillor Hazel Perham of Treverva who passed away on February 21st.

16-191 SAFETY PROCEDURES

The Chairman explained the safety procedures.

16-192 TO RECEIVE AND ACCEPT APOLOGIES FOR ABSENCE

All Councillors were present at this meeting.

16-195 TO RECEIVE AND APPROVE THE MINUTES OF THE COUNCIL MEETING HELD ON 30TH JANUARY 2017 AND THE CHAIRMAN TO SIGN THEM

The Clerk gave information on the part of Budock parish that is within the AONB. Correspondence is still ongoing regarding street names for the Union Corner development.

16-197 TO RECEIVE ANY POLICE UPDATES

No updates have been received from PCSO Fuller. The latest information on the Police website shows three crimes occurring in the parish in December – one in the 'Anti-Social behaviour' category at or near School Lane, one in the 'Violence or Sexual Offence' category at or near Penwarne Road and one in the 'Other Theft' category at or near No Mans Land Road. The latter two are showing as still being under investigation. No investigation details are provided for the first crime.

16-199 TO RECEIVE A PRESENTATION FROM EJFP PLANNING WITH REGARDS TO THE POTENTIAL FOR A HOUSING DEVELOPMENT ON THE SOUTHERN EDGE OF BUDOCK VILLAGE

Ed Persse from EJFP Planning gave a short presentation regarding housing development on the southern edge of Budock, followed by a two-way Question and Answer session. They will keep in touch with the council with regard to the progress of our Neighbourhood Development Plan and any identified affordable housing needs.

16-200 TO RECEIVE AN UPDATE ON THE NEIGHBOURHOOD PLAN 'PUBLIC MEETING' HELD ON 15TH FEBRUARY

Cllr Heritage gave an update on the Public Meeting held on 15th February. Mark James from Cornwall Council had answered questions and by the end of the meeting t7 people came forward who were seriously interested. Cllr Heritage will act as the temporary Chairman and Cllr Fairbank is willing to act as Treasurer. At Mark James' suggestion it is planned to set up an informal meeting between members of Feock NDP steering group and those potentially interested in being part of ours.

16-201 TO CONSIDER AND APPROVE THE APPOINTMENT OF A NEW INTERNAL AUDITOR

The Clerk gave details of a potential new Internal Auditor, with details of his experience and quotation.

It was proposed by Cllr Geraty and seconded by Cllr Bennett and:-

RESOLVED that Steve Hudson be appointed as our Internal Auditor for this year.

On a vote being taken this was unanimously approved.

16-202 TO CONSIDER AND APPROVE THE COST OF REPAIRING A DAMAGED PARISH BOUNDARY STONE

.After discussion it was decided that before we agree to the cost of repairing and replacing the damaged stone that Cornwall Highways be contacted to see if there is a less vulnerable position for this stone to be sited. Also it will be confirmed if one or both stones in the Argal Dam vicinity are damaged.

16-203 TO CONSIDER PARTICIPATING IN THE 'BATTLES OVER - A NATION'S TRIBUTE' COMMEMORATION

After discussion it was proposed by Cllr Hennell and seconded by Cllr Fairbank and:

RESOLVED that an interim email is sent expressing our interest in taking part, if a suitable site can be found on which to light a large bonfire.

On a vote being taken this was unanimously agreed.

16-204 TO RECEIVE INFORMATION FROM THE CLERK ON THE PROCEDURES FOR THE FORTHCOMING ELECTIONS

The Clerk reiterated the information on the procedures for the forthcoming elections. All Councillors have received the relevant CALC produced leaflets on this.
