MINUTES OF THE ANNUAL AND 902ND MEETING OF BUDOCK PARISH COUNCIL HELD AT BUDOCK VILLAGE HALL ON MONDAY 22ND MAY 2017

17-27 TO RECEIVE AND ACCEPT APOLOGIES FOR ABSENCE

17-28 TO ELECT A CHAIRMAN FOR THE YEAR 2017/18

Cllr Hart was asked if he was willing to stand as Chairman for a further year.

It was then proposed by Cllr Hennell and seconded by Cllr Bennett and:

RESOLVED that there being no other nominations Cllr Hart be elected Chairman for the Year 2017/18

On a vote being taken this was agreed unanimously.

Cllr Hart then signed the Chairman's Acceptance of Office.

Treverva Chapel – Cornwall Council is responsible for Grade 2 listed buildings – a possibility their conservation officer
could charge for his services. Falmouth & Gwennap Methodist Circuit Property Committee are aware of the Council's
concerns and do visit the property from time to time.

The Clerk will contact Cornwall Council again with the Parish Council's concerns.

- Wild Eyedeer Public Consultation Since this consultation the Parish Council has received a copy of a letter to Cornwall Council Planning from a neighbour, expressing concerns regarding the proposed development.
- Annual Return This has been sent to Grant Thornton. The proposed dates for the accounts being available for public
 consultation are 20th June to 31st July inclusive.
- Internal Audit The Internal Auditor has accepted the proposals regarding keeping a record of Purchase Orders.

17-34 TO RECEIVE ANY POLICE UPDATES

No updates have been received from PCSO Fuller. The latest information on the Police website shows two crimes occurring in the parish in March. These both came under the 'Violence and Sexual Offences' category. One crime took place in or near Watersmead Parc, Budock Water – suspect identified but unable to prosecute. The other took place at or near Trewen Road, Budock Water and is currently under investigation.

17-35 PUBLIC PARTICIPATION / COMMENTS ON ITEMS ON THE AGENDA

The member of the public present did not have any comments to make.

17-36 TO RECEIVE A NEIGHBOURHOOD PLAN UPDATE AND TO CONSIDER ANY ACTIONS REQUIRED

Cllr Heritage gave the meeting an update on the last meeting that took place on May 8th.

- A Designation Plan has been sent to Cornwall Council and been approved.
- The number attending the meetings has increased to about a dozen people which is very positive.
- A Communications Plan is being formed, and the process to draw down funding is being investigated.
- The drafting of a Community Questionnaire will be considered at the next meeting on the 5th June.
- Meetings will regularly take place on the 1st Monday of the month.

17-37 TO CONSIDER THE CHANGES TO CORNWALL COUNCIL'S STRATEGIC PLANNING PROCEDURES

Changes to Cornwall Council's Strategic Planning procedures were agreed at the last meeting of Cornwall Council before the Local Elections. These mean that Cornwall Council Divisional Members can represent their parishes' views at Strategic Planning meetings, but cannot vote on any applications within the parishes they represent. Also speakers both for and against an application can no longer be questioned on their presentation. Planning Applications automatically go to Strategic Planning Committees if the development is for over 200 houses and/or the site is over 5 acres.

After discussion it was proposed by Cllr Hart and seconded by Cllr Geraty and:-

RESOLVED that the Clerk will write to the Portfolio Holder for Planning (when appointed) at Cornwall Council guerying the reasons for the changes and expressing our concerns over them.

On a vote being taken this was unanimously agreed.

17-38 TO CONSIDER THE PROBLEM OF THE NOTICEABLE INCREASE IN DISCARDED 'POO BAGS' THROUGHOUT THE PARISH

The Clerk reported that Cornwall Council no longer install Dog Waste Bins and do not allow their installation on their land. If the Parish Council install them, then a collection charge of £3.80 per bin per week is made by Biffa.

A discussion followed, particularly relating to the wording of 'Notices' that can be put up near the worst offending areas. The Clerk will contact the Dog Warden for advice on the appropriate wording of any notices, and report back at the next meeting.

One member of the public left the meeting at 8.00pm

17-39 TO CONSIDER PLANTING A 'TREE CHARTER LEGACY TREE'

After discussion, noting that there were no costs involved, it was proposed by Cllr Hennell and seconded by Cllr Geraty and:-

RESOLVED that the Parish Council sign up for a 'Tree Charter Legacy Tree'

On a vote being taken this was unanimously approved.

There is still no Council for Cornwall as an agreement between the political parties has not yet been reached. The Council is currently being run by officers. There are now 46 Conservative Councillors, 37 Liberal Democrats and 30 Independents. It is looking as if a coalition will be formed between the Liberal Democrats and Independents. This could well be finalised at a full council meeting on 23rd May.
