Particular care must be taken to ensure that the trees on NW and NE elevations are adequately protected from damage during construction. The bat and owl survey states the building is not suitable as a roosting or nesting site, however bird boxes can be located nearby to encourage this and could be conditional. Further light pollution from exterior lighting can also be reduced to lessen the impact in this location which is close to the green buffer ( reference the NDP ) measures such as low-level output lighting and timers should be conditional.
