21-151 REPORTS FROM COMMITTEES AND REPRESENTATIVES

Footpaths and rights of way - Nothing to report.

Budock Village Hall – Future of the Hall is at present uncertain. The committee does not seem to be able to form a complete set of officers. Since the death of Peter Fairbank there has been a vacancy for a treasurer, but no one is coming forth with an offer to fill this position.

If a management committee cannot be formed, then the running of the Hall may well devolve to the Custodian Trustees - Budock Parish Council. Enquiries are underway as to what this may involve.

Treverva Village Hall – AGM has been held. They have had a quiet year with bookings but are on a very firm financial footing as they received Government/Cornwall Council grants during the past year. There was discussion as to whether the 100 Club should continue as it has an extremely limited number of subscribers. There is a possibility that new heating system could be installed to replace the inefficient system in place now.

The hall has opened to users and has been used once for a party with a further one booked. We are in discussion with the Young Farmers and hope to see them return to using the Hall.

Playing Field - No report.

Litter Pick - None were possible this month.

21-156 UPDATE ON THE TRAFFIC CALMING FEASIBILITY STUDY FOR BUDOCK

Cllr Hart updated the council on the request received for suggestions on the key areas in the village that should be considered for this study and agreed to reply on behalf of the council.

Cllr Bennett has given his resignation since he will be moving away from the area.

The Chairman thanked him for his hard work and commitment to the council and to the parish over a number of years and wished Cllr Bennett and his wife well from us all with the next chapter in their lives.

Due to the resignation of Cllr Bennett a new Vice Chair will need to be appointed. Cllr J Bastin was nominated and was then elected. Cllr J Bastin then signed the declaration of office.

It was proposed by Cllr Bennett and seconded by Cllr Hart and: -

RESOLVED that Cllr J Bastin be appointed as the Vice Chair of Budock Parish Council.

21-159 TO APPOINT A NEW TREE WARDEN

A new tree warden was needed after the resignation of councillor Bennett. Cllr Grounds was happy to take on this role and therefore is now the tree warden for Budock Parish Council.

21-160 TO CONSIDER SUPPORT FOR THE REQUEST FROM BUDOCK WATER PLAYING FIELD IN CLAIMING \$106 MONEY

Cllr Brierley explained to the council that the Budock Water playing field are applying to the National Lottery Community Fund and match funded by the County Councils S106 money to maintain and improve the facilities of the playing field. They are asking for support in principle not financially for the project. The members agreed to this.

It was proposed by Cllr Hart and seconded by Cllr Grounds and: -

RESOLVED that Budock Parish Council supports in principle the application been submitted by Budock Water Playing Field to both the National Lottery Community Fund and Cornwall Council S106 money for improvement to facilities to the Budock Water Playing Field.

On a vote being taken this was unanimously agreed

21-161 TO REVIEW MINUTE C3657 AND AGREE CHRISTMAS TREE COSTS

The minute sets out the agreement to financial support for a Christmas tree in both villages. After discussions it was agreed that if required continue financial support would be available for both Budock and Treverva towards the Christmas tree. The maximum sum for Treverva for a period of three years would be £50 per year and £100 per year for Budock on an ongoing basis as agreed in minute C3657 from 2013.

It was proposed by Cllr Hart and seconded by Cllr Grounds and: -

RESOLVED that financial support for the annual Christmas tree would be a maximum of £100 per year for Budock village and £50 per year for Treverva village if required, Treverva would be in place for 3 years and Budock on an ongoing basis as agreed in minute C3657 from 2013.

On a vote being taken this was unanimously agreed

21-162 TO DISCUSS THE DONATION TO THE POPPY APPEAL

The members talked about donating to the 2021 poppy appeal and the sum of £50 was agreed.

It was proposed by Cllr Hart and seconded by Cllr J Bastin and: -

RESOLVED that the sum of £50 be donated to the 2021 poppy appeal on behalf of Budock Parish Council.

On a vote being taken this was unanimously agreed

21-163 TO ELECT A MEMBER TO SIT ON THE PLANNING WORKING GROUP

Due to the resignation of Cllr Bennett, there will now be a vacant place on the planning working group. This was agreed to be revisited at a later meeting due to the vacant seats currently available on the full council. In the interim the current members of the planning working group will continue to advise the council on new planning applications.
