## 21-125 REPORTS FROM COMMITTEES AND REPRESENTATIVES

Footpaths and rights of way – 2 issues to be reported to the countryside agency this month.

**Budock Village Hall** – Village Hall had planned a meeting on Thursday 23<sup>rd</sup> to hopefully fill the vacant positions of Secretary and Treasurer. This was cancelled due to the sudden death of Peter Fairbank.

The Hall is open and being used. Quotes have been received from one source for 'New Roof on Village Hall'. Normally three quotes for the same description of work are required.

**Treverva Village Hall** – Committee meeting was held on 16th August. It was agreed that the price for any near term bookings could be reduced and that the booking secretary, Mrs G Bennett, was authorised to decide a price with anyone wishing to book the Hall. The telephone number for booking the hall on the notice board will be changed to 01326 340779. Disabled access to the toilet is restricted by the limited opening of the sliding door. The village hall AGM will be held Monday 18 October at 7 pm.

Playing Field – Next meeting 30th September 2021.

**Litter Pick -** There were two attempts at an August Litter Pick, but both were defeated by the weather. September was a little more successful and on Saturday 18<sup>th</sup> three people attended. We cleaned from the Village Hall to Crill Corner and upon our return we went around the playing field.
