### Chairman's Report 2022 - 2023

There have been several ups and downs in Council membership over the last twelve months. We did however finish the year with a full Council of 10 members, these being ten residents of the parish who are prepared to give up spare time to serve their local community.

In June, to mark the Queen's Platinum Jubilee, a bench with suitable plaque was purchased. It has been sited in the Pump Garden for the use of residents and those waiting for buses.

Throughout a large part of this last year, we were involved with a planning application to build houses on the land earmarked as a boundary between Budock and it's neighbour Falmouth. After a long battle this application was refused by Cornwall Council thus preserving Budock from coalescing with Falmouth.

Again, this year we have continued with arranging the weed control on roadside edges and verges together with the routine cutting and maintenance of the major footpaths within the parish. These footpaths are an essential part of the heritage and assets of the parish and are enjoyed by locals and visitors alike.

Unfortunately, we still have great concerns regarding developers and their apparent desire to build on every piece of land that abuts to Falmouth as we have just discovered that the developers mentioned above have now appealed Cornwall Council's decision.

It would appear that the opinions of the population and the need to protect the rural nature of this part of the Parish count for nothing in the developers' eyes, they are only interested in building houses wherever they can and the profits that these houses will bring for them.

These houses not actually needed, and the land would be better left as a green belt to define the boundary of Falmouth and Budock.

If anyone reading this report feels that they can spare time to assist at the Playing Field or either of the Halls, then please do so as these assets are looked after by a handful of volunteers some of whom have been doing so for many years. ### The Year Ahead

In view of upcoming changes in legislation the Council are aiming to preserve the Parish in a number of ways.

In June 2022, a 20mph speed limit was introduced into the village. I am pleased to report that the number of vehicles exceeding this limit is reducing month on month. It is hoped that another Speed Visor may be installed to help this process, investigations will also be made as to whether a Community Speed Watch can be brought into being this can help to monitor speeds on a real time basis with offenders being reported to the police. These measures will help the residents to move around the Parish more safely at the same time helping to reduce pollution from motor vehicles.

We will be strongly resisting building developments which are not in accordance with the Budock Parish Neighbourhood Plan so that we may continue to enjoy the rural nature of the parish as a whole. The Parish Council is not against the building of houses, but we feel that any building should take place in unobtrusive and sustainable sites.

It is felt that it is incumbent upon the Council to ensure that the Parish is a pleasant and safe place to live in and carry on our normal day to day lives. As part of this we all, Parish Council, and residents, must do everything we can so that the local environment can be kept clean and tidy for the enjoyment of all.

We should all remember that this Parish is where we live and realise how blessed we are to have the countryside all around us and know it should be respected.
