#### 23-131 TO UPDATE ON COMMUNITY SPEED WATCH INITIATE FOR BUDOCK VILLAGE

Cllr Spear submitted a written report:

#### **CSW and Traffic Speed Update**

Traffic Speed remains consistent entering the village from the North with the average remaining around 22.8 MPH for the last four months. Since the speed criteria was expanded in July, the number of those entering the village from the North has been between 35 and 37 thousand per month with higher figures over July and August as we would expect.

There is clearly still a need however for the CSW as numbers in excess of 25MPH are still circa 5 thousand per calendar month although it is pleasing to see higher speeds have reduced.

Regarding the CSW, I have had no further volunteers, but another 30 CSW pamphlets have been sent to the Village Store as all previous 30 provided have been taken. I fear the same lack of interest with these hence starting the conversation regarding an appropriate type of Newsletter to inform of this and other activity that would benefit all of us.

#### 23-132 TO DISCUSS THE CONDITION OF THE TREVERVA DEFIBRILLATOR COVER AND AGREE COSTS OF A NEW ONE

Councillors fully discussed the options, and it was agreed that the clerk would investigate current prices and report back. Cllr Saunby has agreed that an application to his community chest fund can be made for part of the costs.
