**Playing Field** – We had a successful Christmas lights switch on although erecting and dismantling the Christmas tree was somewhat stressful with us being unable to work around users of the hall. We were grateful for Pendennis Brass band who came to play too. The grant applications have all been completed and we are now solely awaiting the better weather to enable work to start on the playing field. Our next event is the Easter Treasure Hunt, and we expect to have a normal meeting within the next few weeks.
