# 24-15 TO UPDATE ON ENFORCEMENT ISSUES

A meeting had been held in the Treverva Village Hall about the polytunnel and enforcement concerns.

It has been agreed that a door-to-door investigation will take place to gauge the current view of the residents of Treverva about this development and the action of the Cornwall Council enforcement team and the findings reported back to the parish council.

#### 24-16 TO UPDATE ON THE PERSIMMON APPEAL

A meeting was held with parish councillors, the divisional member, and the Cornwall Council legal team.

They were informed that Cornwall Council would not be taking any further action. Cornwall Council commented on the extent of work that parish councils and the divisional member had put into this appeal. A letter to this effect from Cornwall Council will be put on the parish council's website and a report sent to the Falmouth Packet.

### 24-17 TO UPDATE ON THE METAL FINGER POST SIGNS IN THE PARISH

The finger posts are the responsibility of Cornwall Council there is supposed to be a rolling 5-year refurbishment plan in place. The clerk has spoken to a highways officer who has said there is not enough money to refurbish them as they are not safety critical. They have offered the materials (paint and brushes) for local volunteers to conduct the work, but they will not cover PPE or traffic management (where applicable) or insurance to cover risk. The clerk has made enquiries for an independent contract to conduct the work and is waiting for the quotes to be submitted and the diversional member has been asked to clarify with Cornwall Council the current situation with the 5-year rolling programme. It was agreed that when more information is available it may be returned to a meeting of the parish council for further comment.

#### 24-19 TO CONSIDER CYBER SECURITY AND DEDICATED LAPTOPS FOR COUNCILLORS

After discussions it was agreed that the capital cost and ongoing costs to supply 10 computers to all members was not an efficient way to spend the precept.

The clerk will investigate in more detail the costs and reasons for changing the domain name as per current recommendations and report back to a future meeting.

#### 24-20 TO UPDATE ON THE CURRENT VACANCY FOR ONE MEMBER OF THE PARISH COUNCIL

Cllr George submitted her resignation last month. The vacancy was advertised as per the regulations and as no election was requested the vacancy will now go for co-option. This will be advertised after the May meeting with the hope of a selection at the June 2024 meeting.
