Playing Field –. The work at the field has been completed. The safety surfacing looks great, as does the astroturf around the goal. The see-saw has returned from Pendennis and is looking suitably smart on its new surface.

There is also an issue with the paintwork for the equipment. The contractors used a 2-pac paint but there was not enough preparation made to the surfacing and the old paint has come off and with the new paint going hard it has left sharp edges. For this reason, the climbing frame has been cordoned off and we are seeking redress from the contractors.

We are hoping to run an event to coincide with an official "opening" of the Playing Field but with the work not properly completed I am not sure when this will happen.

Highways also said that such mirrors are a last resort as sometimes the glare from them is also a danger to motorists.
