# **Chairman's Report**

2012/13 has been another year of constant change and uncertainty. Some time ago in 2008 there was a strategic move which was supposed to transform local government in Cornwall, with all services being delivered by the single authority in partnership with the community. Despite promises at the time that a lot more 'power' would be devolved to Town and Parish Councils we are still a long way off this in reality.; I hope with the advent of a new Council following the elections in May that this will now have another chance to happen and that in this time of austerity, funds will be used wisely.

As part of the reconfiguration of local government Budock Parish Council took the opportunity to share a council office with Mawnan Parish Council in Mawnan. Because of changes within the company that provided the office space we have now reviewed our options and decided to put the Clerk's office back into the village within the Village Hall.

One of the main factors affecting Budock Parish this year was the proposed industrial development inside the Parish boundary at Bickland Water Road. Despite objections from Budock Parish Council, Falmouth Town Council and numerous members of the public. The decision to refuse the development by Cornwall Council was over turned by a Government Inspector. This emphasises how Budock is intermeshing with Falmouth, and demonstrates the need for us to be clear on how far we are prepared to allow our boundaries to coalesce while retaining our rural identity, that said there are opportunities for joint working and we have an excellent relationship with Falmouth Town Council.

Public Rights of Way – Over the past few months we have been reviewing our Footpaths and Bridal ways and it has become clear that some are in need of rejuvenation as a result mainly of the extreme winter. Hopefully this work will take place over the next few months ready for next winter. The number of people using our rights of way has increased considerably over the last few years and this in itself increases the wear and tear aspect.

The role of a parish councillor has changed substantially over the years with more responsibility, accountability and time commitment, but it can be very interesting and rewarding. We currently have vacancies following the local elections for two members. It is particularly important to have councillors with a history of local knowledge, and also epresentation from the younger sector of the community. If you would like to know more about what would be involved please speak to me or the Parish Clerk.

Local community spirit has shone this year, with many actives taking place. In particular the Christmas lights and gave an opportunity for people to get together. Another success story has been Budock Playing Field, where young children can let off steam and interact safely. I thank the Playing Field and Village Hall Committees for their enthusiasm and commitment. As with the Parish Council, they rely on volunteers and are always keen to find new members. Budock Garden Show has also gone from strength to strength and with a renewed interest in 'home grown' and allotments gives the opportunity for local gardeners to showcase their products with of course the usual friendly rivalry.

Crime and disorder is still relatively low within the Parish but this should not lead to complacency. We also have a continuing issue of vehicle speed within both Budock and Treverva.

Finally I would like to place on record my thanks to all past and present members of this council, the Clerk and also to our County Councillor Neil Hatton for his loyalty and hard work in supporting the Parish and its community.

# Footpaths and Public Rights of Way

Footpaths and Public Rights of Way are some of the most valuable assets of the parish. Not only do they serve a useful purpose in enabling people to get around the parish without using cars or public transport, they also provide amenity spaces for everyone to enjoy.

Following a Cornwall Council reassessment of the parish paths several years ago and prior to improving some of them and upgrading others to Gold Standard, the maintenance agreement was looked at again. While most of the paths in the parish had previously been classified as requiring to be trimmed twice each year, many of them are now only subject to this regular maintenance once each year.

The Parish Council acts in partnership with the Cornwall Council, and appoints and pays its own maintenance contractor to do this work. When the work has been carried out satisfactorily, we are then able to claim back most of the cost from Cornwall Council. Now that some paths are only routinely trimmed once each year, it may be that some will get overgrown in between the scheduled cuts. If you find this to be the case, please let the Parish Council know about it – although we cannot guarantee to have the work carried out as money might not be available, we can ensure that the Highways Authority in the Cornwall Council are made aware of the problem. Cornwall Council is ultimately responsible for maintaining the paths in a satisfactory condition, but again that will be subject to budgetary constraints!

Please remember that the Parish Council (acting as agent for Cornwall Council) is only responsible for any growth **underfoot** on the paths – brambles, nettles, branches etc growing out from the edges of fields or walls are the responsibility of the landowner to keep trimmed in order to keep the path open and clear! The landowner also has a legal responsibility to reinstate any footpath, bridleway or byway that they plough or disturb when sowing or cultivating a crop, and this must be done within 14 days of the first disturbance. Any subsequent disturbance to the Right of Way must be made good within 24 hours unless the landowner has been allowed an extension by the Cornwall Council. If you come across cases where the path has not been reinstated properly, please inform the Parish Council, or alternatively let Cornwall Council know about it by using their website and filling out a Public Rights of Way Report Form. It is also important to remember that any Right of Way is identified as such on the Definitive Map, and unless the landowner allows access to other areas of their land, you must stick to the actual footpath and not wander off the path.

The Parish Council is currently undertaking a revision of the footpaths leaflet complete with photographs, with the intention of encouraging more people to use and enjoy the paths. It is hoped that this leaflet will be published before the summer and will be distributed via tourist information centres, local shops, pubs and libraries.

One final point – if you walk along the paths with your dog, please remember to clear up after it. Bins for dog and other waste are sited around the parish, so please use them and keep the paths pleasant for everyone to enjoy. If more bins are needed, then please let the Parish Council know and we will try to get funding for some more.
