## 18-243 TO CONSIDER PLANNING APPLICATIONS RECEIVED FROM CORNWALL COUNCIL

i) PA17/01782 – Demolition of existing property and construction of a new dwelling house and detached garage – Parkside, Penjerrick Hill – Mr S Silcock

A site visit was carried out for this application and the Councillors who attended reported their findings to the meeting. It was proposed by Cllr Fairbank and seconded by Cllr Bownas and:-

**RESOLVED** that the following comment be submitted:- "Budock Parish Council supports this application, which will replace an old, substandard dwelling. The proposed re-build will provide a modern, energy-efficient home which will go beyond what is required by current building regulations. We feel that the modern design will, in the context of its location, meet the objectives of the NPPF and the emerging Neighbourhood Development Plan. However, the existing dwelling and associated extensions and outbuildings appear currently to be ideal roosting and nesting spaces for bats and

- From 1st April Cornwall Council Concessionary Bus Passes can now be used 24/7.
- Cornwall Council's Road Safety Event is now taking place on 14th May.
- Truro's Park & Ride is extending its opening hours.
- Enforcement has received no response from Midas regarding the lack of Cornish hedges on their Bickland Water Road development.
- Another meeting has taken place with the Site Manager of the Taylor Wimpey development aware of problems caused
  by the traffic lights on Bickland Water Road. The current lights will be removed shortly but there will be lights for 6 weeks in
  June and July when a Pelican Crossing is installed and other work carried out.
