MINUTES OF THE 931ST MEETING OF BUDOCK PARISH COUNCIL HELD AT BUDOCK VILLAGE HALL ON MONDAY 27TH JANUARY 2020

19-196 TO CONSIDER PLANNING APPLICATIONS RECEIVED FROM CORNWALL COUNCIL

i) PA19/10922 Proposed barn conversion with variation of conditon 2 in respect of decision PA18/12102 - Redundant Barn, Argal Manor, Kergilliack - Mr & Mrs C Spencer

It was proposed by Cllr Hennell and seconded by Cllr Hart and:-

RESOLVED that the following comment be submitted:- "Budock Parish Council support this current application and the removal of Condition 2 imposed in the previous application PA18/12102. We feel our original comments remain valid".

On a vote being taken this was agreed with one abstention.

ii) PA19/11161 Proposed change of use/conversion of barn into dwelling including septic tank and additional landscaping - Menehay Farm, Budock Water – Mr & Mrs A Dunstan

It was proposed by Cllr Geraty and seconded by Cllr Heritage and:-

RESOLVED that the following comment be submitted:- "Budock Parish Council strongly support this application. The conversion of this redundant farm building will result in a modern, energy-efficient home which conforms to several of the policy requirements of the Cornwall Local Plan. Furthermore, it meets the aims of the emerging Neighbourhood Development Plan.

This site being a sensitive area for wildlife, we seek to reinforce the recommendations of a bat and owl survey."

On a vote being taken this was agreed with one abstention.

19-197 TO RECEIVE ANY POLICE UPDATES

Information was given on the crimes in the parish in October (no crimes) and November (one reported crime of Violence and sexual offences on or near Penwarne Road. This is currently under investigation). Details of crimes can be found at https://www.police.uk/devon-and-cornwall/CIOS.4068/.

19-198 SPEED VISOR UPDATE - SITING OF UNITS AND AGREEMENT TO PROCEED

Cllr Bennett reported that Highways have now agreed on locations in Treverva and Budock for the siting of Speed Visors. They will proceed with the installation once payment has been received. The plan is to pay for the Treverva visor this Financial Year and the Budock one in the next Financial Year (after April 2020). The amounts payable and agreed sitings were discussed. Cllr Bennett explained that the visors cannot be sited on private land and have to be 50cm off the highway. Concerns were raised regarding possible light intrusion into private dwellings from the visor and it was agreed that Highways would be questioned on this and if necessary confirm whether a shield could be placed on the visor. This will be done before the next meeting. A question was also raised regarding the collection of data from the visors, but this was thought not relevant as Cornwall Council would be responsible for the visors and the parish council is not in a position to act on any data.

19-199 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL DIVISIONAL MEMBER

Cllr Bastin reported on the following:-

- Update given on changes to waste collection from October 2020 recycling will be fortnightly, as will general
 waste collections. By October 2021 households should all have been provided with wheelie bins which will hold
 up to three black bags. Food waste will be collected weekly and containers provided.
- The next Community Network Area meeting is at Mylor on 28th January preceded by a Climate Change group meeting..

19-200 REPORT ON BOUNDARY REVIEW - CURRENT SITUATION AND WHERE WE GO FROM HERE - CLLR BASTIN

Cllr Bastin gave an update on the progress of the Boundary Review. The Boundary Review panel has not accepted recommendations from Budock or Falmouth councils and so responses made during the Public Consultation period need to be powerful if any changes are to be made. The parish council will be meeting to evaluate the information received to date and to decide on their response to it.

19-201 REPORT ON LATEST VILLAGE LITTER PICK

Cllr Hart reported that five bags of rubbish were collected on the last pick in Budock village a few weeks ago. Several appreciative comments have been received from the residents.

19-202 TO RECEIVE A NEIGHBOURHOOD PLAN UPDATE – DISCUSS AND DECIDE SETTLEMENT BOUNDARY ISSUES Clir Heritage gave the following update:-

In the Pre-submission Consultation, two requests were received to extend the agreed 'Settlement Boundaries'. The NDP Steering Group had agreed these boundaries taking into account the evidence of the need for new houses in the parish. This had been proposed as 20 in Budock village and up to 5 in Treverva and Lamanva. These would take the form of 'infill'. A discussion took place as to whether there was a need to change the agreed settlement boundaries.

It was proposed by Cllr Heritage and seconded by Cllr Hart and:-

RESOLVED that the Settlement Boundaries in the emerging Neighbourhood Development Plan remain as proposed.

On a vote being taken this was agreed with one abstention.

19-203 THE CLIMATE AND ECOLOGICAL SITUATION – TO IDENTIFY A PORTFOLIO HOLDER OR ESTABLISH A WORKING GROUP – DISCUSS

It was agreed that no action need be taken on this at present. Cllr Bastin reminded the council that there is a Climate Change Group that meets before the Community Network Area meetings and that any councillor is welcome to attend these.

19-204 GRANT REQUEST OF £534 FROM BUDOCK COMMUNITY ACTION GROUP TO COVER WEBSITE SET UP COSTS - FOR DISCUSSION

Prior to the meeting all Councillors had been reminded about the conditions in Grant Policy. As this group has already received one grant this financial year, and currently has no constitution in place, it was agreed to take no action on this request for the moment.

Cllr Geraty suggested that the group could set up a Facebook page. The Playing Field Committee have set one up and find it more than adequate in getting across all the relevant information.

19-205 ALLOTMENTS FOR THE PARISH – REPORT FROM CLLR GERATY

Cllr Geraty reported that there was a possibility that a Budock landowner would release some land for allotments. He is meeting with one of the trustees and will report back to the council.

19-206 BUDOCK VILLAGE HALL – NEW REP TO BE APPOINTED

No Councillor has volunteered to be the council's rep on the Village Hall Committee. Both the parish council and the Village Hall Management Committee have their AGMs in May and a rep should be agreed by then.
